## BREAST CANCER AWARENESS SESSION

Memon Professional Forum (MPF) organized Breast Cancer Event on October 31, 2022 at Karachi Gymkhana to spread awareness among masses and not to limit the awareness campaigns to the month of October only.

The session under the patronage of the First Lady, Begum, Samina Alvi was very informative for our female audience where she addressed about the campaign and emphasized on the early diagnosis to prevent the cancer.

Prof. Dr. Rufina Soomro and Dr. Saira Bano were the other speaker and host for the seminar. Key notes from the address of Begum Alvi were as follow:

- 50pc of the deaths caused by the breast cancer in Pakistan are due to the late diagnosis.
- fortunately after the commencement of the awareness campaigns stigma attached to the disease had minimized which indicate that taboo is declining rapidly.
- emphasized upon sensitizing men to participate in the campaign.

Speaking on the occasion, Dr Rufina Soomro said the breast cancer is the most common cancer among the women and explained the three-step approach required for good breast health that include self-examination, clinical examination and mammography.

Two breast cancer survivors also supported the event with their presence and highlighted the importance of self-examination and timely diagnosis in their addresses. Participation from the survivors besides doctors was appreciated by the First Lady and audience.

## CORPORATE REGULATORY UPDATES

### - SECP issues Asset Backed Securitization Regulations, 2022

SECP, through S.R.O. 2135 (I)/2022 (dated December 01, 2022) issued Asset Backed Securitization Regulations, 2022. The Regulations apply to the offer of debt securities, including redeemable capital, debentures and sukuk by the Special Purpose Vehicles (SPVs) under the securitization process.

The asset-backed securitization is governed by Asset- Backed Securitization Rules, 1999, and the Regulations have been issued to provide a holistic regulatory framework.

### - SECP issues amendments to the Companies (Postal Ballot) Regulations, 2018

SECP has issued amended Companies (Postal Ballot) Regulations, 2018 which requires company's to provide its members the right of vote through postal ballot/ electronic voting in the manner prescribed therein. Furthermore, listed companies are also required to appoint scrutintizer who shall perform the duties as envisaged in it. **- SBP issues Environmental & Social Risk Management implementation manual for Financial Institutions**

The State Bank of Pakistan through IH&SMEFD Circular Letter No. 12 of 2022 (dated November 09, 2022) issued the Environmental & Social Risk Management (ESRM) implementation manual for Financial Institutions. SBP expects the banks and DFIs to fully implement the ESRM within three (03) years of issuance of this manual.
